## US company buys LatAm oil inspection group

US oil inspection company AmSpec has hired a slew of Latin American law firms to buy Texas-based counterpart Oil Test Internacional, expanding its presence in 13 countries across the region.

Marval O'Farrell Mairal in Buenos Aires, Bolivia's CR & F Rojas Abogados, Chilean firm Claro & Cía, Brigard Urrutia in Bogotá, Pérez Bustamante & Ponce (PBP) in Quito, Romero Pineda & Asociados in San Salvador, Mayora & Mayora (Guatemala), Honduras' GUFA Law and Guyer & Regules in Montevideo all advised AmSpec.

Latin Lawyer understands that AmSpec also hired Facio & Cañas in San José; Alvarado y Asociados in Managua; Panamanian firm Arias, Fábrega & Fábrega and Peroni, Sosa, Tellechea, Burt & Narvaja in Asunción, but these details could not be confirmed before publishing.

The target relied on its in-house counsel for the deal, which closed on 31 March for a confidential amount.

AmSpec adds to its portfolio of oil testing, inspection and certification assets with the acquisition, which marks the buyer's entry into Argentina, Bolivia, Chile, Colombia, Costa Rica, Ecuador, El Salvador, Guatemala, Honduras, Nicaragua, Panama, Paraguay and Uruguay.

The purchase also hands the buyer 78 new inspection facilities, giving AmSpec a total of 341 assets across 77 countries.

With over 35 years' experience in testing, inspection and certification operations, New Jersey-based AmSpec also offers services in the renewables, agriculture, transport and mining sectors.

Houston-headquartered Oil Test Internacional operates a network of 20 offices and laboratories across Latin America. The company was founded in 2003 and worked in affiliation with AmSpec for 14 years prior to the acquisition.
