He also contributed to the technical commissions for the draft laws on Foreign Exchange Liberalization and the Monetary Law.

He has acted as legal counsel in most securities issuances by Guatemalan banks and companies in the New York market under Rule 144A, and has advised the board of Guatemala's stock exchange for over three decades. Additionally, he has served as both counsel and arbitrator in domestic and international investment and commercial arbitrations.
